FROM THE PRESIDENT

The Ohio Association website (www.usatf.org/assoc/oh) is always a place for useful information on meets and events in your association. Check it often; it usually answers many of your questions.

I want to inform you of the many changes that occurred during the annual meeting of USATF in Reno.

1. Restructuring of the Board of Directors took place at the opening session on Wednesday, December 3 2008. The board will now be reduced from 29 members to 15 members. The current board will have the look and feel of an executive committee. By the time you read this our new board will be on the way to reality. The hope is that the new board will be in place prior to the end of the first quarter of 2009.
2. I was elected Chair of the Association's Committee and look forward to the opportunity to lead the Associations at the national level for the next four years. I will continue to be your President and would welcome your comments and suggestions.
3. Our own Ohio Official's Certification Chair, Len Krsak was elected as the National Official's Chair. I'm sure you will hear more from him.
4. Stephanie Hightower was elected President of USATF. We look forward to her leadership over the next four years.

This gives me great pleasure to see so many people from Ohio working at the National level.

Next year the annual meeting will be held in Indianapolis and I would encourage you to make that drive if only for a couple of days. I talked to a few people from Ohio who went to Reno and attended the meeting for the first time. They stated that it was a real "eye opener on how everything occurs".

One of the goals this year will be to work with Gary Morgan to help the various associations contact local elite athletes to increase their participation in the association's events. More on this to come.

Look for many changes over the next few months as we try to increase communication between the Associations's Committee and the local associations.

The next item to come out of the annual meeting is that the background screening process going to the National office. Beginning January 1, 2009 the national office will begin processing the background screening of the coaches and volunteers. More information will be going out to the youth clubs soon. It was evident to us that not all coaches and volunteer of the clubs participated in the background screening process. I encourage you as parents of youth athletes to check our website often to see if your club coaches appear on the list of those in good standing.

The 2009 Association Workshop will be August 27-30, 2009 in Des Moines, Iowa. If anyone is interested in attending the workshop please contact one of your board members for information.

We are also continuing to move forward in obtaining a Level II Youth Coach Program. We have many committed to making this happen. Stay tuned for more details in the coming months.

YOUTH ATHLETICS

2009 IAAF WORLD CHAMPIONSHIPS

July 8th to 12th, 2009, Bressanone, Italy

The World Youth Championships are for 15, 16 and 17 year old athletes.

For the first time, the team will be selected using a trials process. The trials event will take place at Eastern Michigan University in Ypsilanti, Michigan on June 30 and July 1. As is the case with our elite athletes and their teams, our youth athletes will be able to 'select themselves' based on how they perform at a qualifying meet. To qualify for the trials meet, athletes must: be a 2009 USATF member, hit a qualifying standard and have a current US Passport. (Please note, as the team will depart for Italy on July 3rd, no athlete will be allowed to participate in the trials event without a Passport).

COACHES BACKGROUND SCREENING

Notice to parents of our youth athletes. Not all of our club coaches/volunteers are having a background screening performed. We can not force background screening. However, if you want to know if the coaches/volunteers working with your son or daughter have gone through and passed the background screening process, go to www.usatf.org and do the following: click on About/Program/Criminal Background Check Program, then click on volunteers/coaches in good standing. Then enter Ohio or your club number to find out if your coaches/volunteers are on the list of coaches/volunteers in good standing with USATF.

Notice to clubs. The process for obtaining background screening is being changed from a de-centralized process (Associations performing the background screens) to a centralized process where all background checks will be processed via an online portal provided by a third-party vendor. Information on how this will be handled can be found on the Ohio Association web-page.

LONG DISTANCE RUNNING

USATF NATIONAL CLUB CROSS COUNTRY CHAMPIONSHIPS

In December 2008, the RUNOHIO – Second Sole Racing Team, the defending USATF Women National Club Cross Country Champions, traveled to Spokane, Washington to defend their team title. With four runners in the top sixteen, Kara Storage (6th – 22:08), Leigh Daniel (9th – 22:11), Tara Storage (14th – 22:31), and Melissa Converse (16th – 22:35), the RUNOHIO team held their own against the best in America. With one runner from last year's winning team out with injuries and another missing the race due to a death in the family, the RUNOHIO team finished a strong fifth place overall with Carmen Baxter rounding out the team scoring to secure the final team prize money.

The 2009 USATF National Cross Country Championships will be held on December 12th in Lexington, Kentucky.

Both individuals have worked meets at all levels including the Olympic Games. It's an honor well deserved and earned and both Ron and Jim's families were there to celebrate the occasion. Additional news from the annual meeting, Karen Krsak is now the Chair of the Association's Committee and Len Krsak the Chair of the Officials Committee. Len is replacing Linda Melzer who has done an outstanding job over the last seven years acquiring benefits for official's nation wide. Another Ohio official that has made her mark is Stephanie Hightower; she is now the President of USATF.

Official's certification for the new Olympiad is well under way. Remember I cannot re-certify anyone without a USATF membership number, which is a different number than your certification number. For the last Olympiad, the Ohio Association had 285 certified officials. As of February 16, 2009 the Ohio Association has 105 officials certified for the 2009-2012 Olympiad. As you can see, we have a challenge ahead of us.

An Ohio Association Officials Clinic was conducted on Sunday, January 25, 2009 at Capital University, Bexley, Ohio. Five presenters gave the following presentations: Starting by Fred Thomas; Throws by Brian Stephens; Long/Triple Jump by Mike Kempf; High Jump by Steve Lower; and Pole Vault by Kip Kinn. Sixty five officials attended the clinic. In addition to the presentations 2008 Ohio Association Officials Awards were presented to 42 officials. The Ohio Association Official of the Year was Lloyd Martin.
