The Annual Meeting of the Association will begin at 1:30 p.m. Only current USATF members who are 18 years of age and older and in attendance (no proxy voting) will be allowed to vote in the meeting. If you are a new member (as opposed to a renewing member), you must have secured your membership by July 31, 2011 in order to vote. If you are a renewing member (from 2010) you must have renewed your membership within thirty (30) before the Annual Meeting. Please **bring proof of 2011 membership** if you have renewed since June 30, 2011.

The Missouri Valley Association of USA Track & Field will hold its Annual Meeting on Saturday, October 1st at the Office of the Missouri Valley Association, 7001 W. 79th Street, Overland Park, Kansas 66204. All members are encouraged to attend and participate.

Positions which are to be elected by the appropriate committees must have been elected in committee meetings which attained a quorum. All officers and chairs must be members of USATF, as must all those who are eligible to vote in committee meetings and has passed background check for USATF. In the event that a committee does not have a quorum of eligible voting members or does not meet to hold their election, such committee chairs will be elected from the floor.
