Minutes of 2008 Annual Meeting Ozark Association USATF

The Ozark Association USATF held its Annual Meeting at the Florissant Valley Branch of the St. Louis County Library on September 17, 2008. There were 31 members present. The meeting was called to order by President Ed Rowold at 7:00 p.m. The minutes of the previous meeting were presented and approved. The Treasurer's report for the year to date was presented and approved. 2008 Individual and Club membership numbers were presented.
