Declaration/Disclaimer

I, the undersigned, acknowledge the regulations of the 2nd World Masters Athletics Championships Indoor as stated in the booklet as well as the IAAF and the WMA rules.

I confirm, I am in good health and that there are no objections against my participation at the championships on medical grounds.

I hereby give my consent to be subject to drug testing at the 2nd WMA World Championships should I be selected to do so.

I relieve WMA, the Organising Committee and/or third parties acting on their behalf as well as all sponsors of any responsibility for any injury, loss or damage incurred in the course of or in connection with the championships.

Doping Control

The organising committee will conduct random doping/drug tests during the championships in accordance with IAAF and WMA rules and regulations. Athletes using any medication which contains a prohibited substance in either the current WADA code or the IAAF Procedural Guidelines for Doping Control (PGDC) will, if testing positive for a prohibited substance, face the penalties prescribed therefor in the corresponding WADA Code or the PGDC unless they are in possession of a written exemption for the use of the substance in question granted by WMA. If necessary this exemption must be produced to the Doping Control Officer at the Linz Doping Control Station at the time of testing.

Note, however, that to solve any conflict between the IAAF PGDC and the WADA Code the following applies: In conflicts regarding exemption applications the provisions of the IAAF PGDC shall apply, and in all other conflicts the provisions of the WADA Code shall apply.

Im Falle einer Dopingkontrolle muss diese Freistellung dem Dopingkontrollbeauftragten in Linz vorgelegt werden.

Team USA Code of Conduct and Waiver

All Masters Athletes and USA Track & Field (USATF) Delegation Managers are required to adhere to the following Code of Conduct as a condition of competing internationally under the auspices of USA Track & Field.

1. I will conduct myself at all times as a goodwill ambassador for USATF and the United States of America, and that I will refrain from any act(s) that may reflect unfavorably upon myself, my teammates, the sport of track and field, USATF or the United States of America.
2. I will not intentionally or voluntarily undertake any action that desecrates or disrespects the American flag.
3. I will dress appropriately and respectfully for all official functions, wearing the designated official USATF uniform top during competition. I understand that I am forbidden from altering or covering up the sponsor logo, if any, on the official USATF uniform top.
4. If I am unable to compete in any event with team awards (4 x 200 relay, race walk, cross country, and half-marathon) due to injury, illness, or for any other reasons, I will notify the USATF Delegation Managers.
5. I understand that it is my responsibility to be informed about all issues related to the competition, and to provide my own equipment and athletic gear to extent that these are not provided by the competition organizing committee, USATF or a USATF sponsor.
6. I will read and abide by USATF Regulation 10/Doping Control and IAAF Anti-Doping Rules. I understand that my failure to abide by the anti-doping regulations may result in disciplinary proceedings against me and the imposition of appropriate penalties, suspension or other disciplinary measures.

USATF may publish and/or release for publication my entry information (name, gender, age, hometown, events, and marks) in accordance with its Privacy Policy

I am voluntarily participating in the 2nd World Masters Athletics Championships (Indoors) and I understand that USA Track & Field (USATF) is providing a service to assist American athletes in entering and participating in said competition, and that USATF does not assume any responsibility for my participation therein. I, for myself, my heirs, personal representatives and assigns do hereby release, waive, discharge and covenant not to sue and do hold harmless USATF, its respective employees, volunteers or agents (collectively “Releasees”), from all liability, loss, claims, demands, possible causes of action, court costs, settlement costs and fees, attorneys fees and any other expenses arising from any claim or lawsuit that may arise from any loss, damage or injury (including death) to me or my property resulting from or arising in connection with, or related to, my participation in the 2nd World Masters Athletics Championships (Indoors).
