

## **Criteria for Selection to the USATF - IAAF Level I Race Walk Judges Panel**

To be considered for the USATF - IAAF Level I Race Walk Panel you must:

1. There is NO age constraint.
2. Be an active race walk judge, having officiated at a minimum of ten (10) sanctioned/recognized events over the last three years.  
Of those events;
  - a.) A majority must have been at Association Championship or higher level.
  - b.) At least six must have been road races.

**And,**

3. Furnish the names and contact information of four (4) individuals who are best able to assess your candidacy for membership on an IAAF Federation Panel of Race Walk Judges.

**Supplemental,**

4. Additional Experience that sets you apart from your colleagues in race walking. Such criteria may include having:
  - a.) Participated at an international competition as an athlete or coach-manager.
  - b.) Past coaching experience of athletes who have competed on the international level.
  - c.) Held Race Walking administrative responsibilities on the National level.
  - d.) Been an organizer of race walk road event competitions.
  - e.) Authored papers dealing with race walking technical matters on judging, technique, and coaching.
  - f.) Etc.
