

USATF 2013 ANNUAL MEETING EXPO SWEEPSTAKES
Official Rules

NO PURCHASE NECESSARY

These are the official rules for the USATF 2013 Annual Meeting Expo Sweepstakes (hereinafter "Sweepstakes").

How to Enter – Entries for the Sweepstakes will be taken at the USATF Merchandise Tent at the 2013 USATF Annual Meeting to be held at the JW Marriott in Indianapolis, Indiana (the "Location") between the "Start Date of Promotion", as indicated below, and the "End Date of Promotion", as indicated below (the "Entry Period"). To enter, participants must completely fill out and submit an Entry Form at the Location. Participants must complete all data requested on the Entry Form to be eligible. There is no fee for filling out the Entry Form. All entries received after the "End of Promotion Date" are void. Winners will be determined among all eligible entries received as of the time of the drawing. Dates subject to change. **No entry fee or purchase is required to enter or win. Void where prohibited by law.**

Prize – One (1) Grand Prize winner will receive two (2) tickets to the 2014 USA Outdoor Track & Field Championships for two (2) days (at Sponsor's discretion) to take place in Sacramento, California, a three (3) night stay for two (double occupancy) at the official Championships Hotel, One Hundred Dollars (\$100) in gift cards to be used towards dinner in Sacramento, California, and an opportunity to present one (1) award during the Championships (Approximate retail value: \$600.00).
